Overview

Clinical Supervision carries with it legal risks as well as a multitude of ethical and boundary issues, whether one is supervising trainees or seasoned professionals. At the same time, *the standard of care* in supervision is typically far less clear to both supervisor & supervisee.

This program examines the risks, solutions and safeguards as regards “negligent supervision.” Gary examines elements of the supervisory relationship as well as related boundary and counter-transference issues. He also discusses supervisory guidance regarding danger to clients or third parties.
